

From the Ministry of Justice we are providing the Administration of Justice with the most advanced technological solutions in order to achieve a more modern, efficient and agile Justice. These initiatives are framed in a global strategic project of Justice for the entire country, the 2030 Justice Plan.



THE ROLE OF THE MINISTRY OF JUSTICE AND THE GDDTAJ IS THREE-FOLD



Like any other ministry, within the scope of its powers (for example: civil registry).



Such as the non transferred Autonomous Communities (CCTTAA) Provision of common services to the whole AJ

Or by own competence (such as SIRAJ) or interoperability node (as notifications).





Justice Folder Development

The use of **electronic means** to interact with the **Administration of Justice**.

A justice system adapted to the needs of citizens, companies and professionals with a personalised service.





Justice Offices in Municipalities

Providing in each municipality the services of the judicial bodies, Civil Registry and other justice services.

with hospitals and notaries and judicial bodies. Currently **17 autonomous** communities and the autonomous cities of Ceuta and Melilla use it and the implementation in different Civil Registries continues.



Communications of guardianships, adoptions, divorces, etc., from the Judicial Bodies. Integration with all procedural management systems during the year 2024 within the framework of the Recovery, Transformation and Resilience Plan – Funded by the EU – Next Generation EU.

Vital Event of Birth in collaboration with the INSS, to grant parents, at the same time the newborn is registered, their maternity/paternity benefits, and even assign a doctor to the newborn for their first check-up by their pediatrician.

Vital Event Death in collaboration with the INSS, to know the status of the person from the moment they die and see the relationships with other people such as spouses (widow's pension if applicable) or children (orphan's pensions), etc.







Electronic procedures in the Judicial Electronic Website

Access to the Judicial Electronic File:

Over **311 thousand** applications processed. **20 seconds** to access the information.

Submission of procedural documents:

Less time spent on integrating all procedural documents in the Judicial Electronic File.




Acceda-Justicia

Allows telematic communication between judicial bodies and legal operators.

The most common procedures used in this Digital Services Portal are:

- Request a copy of the Electronic Judicial File.
- **✓** LexNET Excess Capacity.
- **✓** File routing.

Electronic signature



Portafirmas is the application that allows Justice Administration professionals to sign documents digitally.

Sign with a Centralized
Signature Certificate from any

Manually **GENERATE signature flows** directly from the application.



Allows ACCESS AND SIGNING with a certificate hosted on the mobile device using the @Mobile Signature APK from any location.



Manually CHANGE the location of your signature in a specific document.

Scheduling of Hearings

Displays the hearings on-line, in real time, to see if they are being held, cancelled or, if they are being held, in which room they are taking place.

Courtroom Equipment

As part of the Justice Modernization Framework, a plan has been implemented to improve the courtrooms in order to maximize the quality of the recordings and expand the functionalities of the systems:

COMPONENTS OF THE COURTROOM:



1. THE PODIUM consists of: microphones and IP camera.




2. THE AUXILIARY POST consists of: KVM (to bring audio to the auxiliary post and headphone connection), microphone, VGA duplicator and miniPC.



3. THE RACK consists of: KVM, capture card, audio mixer, network card and workstation (to run the Fidelius application and capture the audiovisual signal).



4. THE VIDEOCONFERENCE AREA: consists of: *splitter, media converter, projector, videoconferencing system.*


A much more competitive State

Robotization Projects



Mechanical and administrative processes can be carried out more efficiently and quickly.



The cancellation of criminal records and the granting of nationality by residence are facilitated.



Robotization of the cancellation of criminal records

Over **430,000** applications of nationality by residence

Over **170.000** applications proposed for granting from July 2022 to September 2023

Between October 2022 and September 2023, over **19.000** minor criminal records have been cancelled.



Al Projects

The automation processes result in the provision of quality public services.

In the Ministry of Justice we have the following Artificial Intelligence projects: Textualization of recordings, legal and forensic dictation and Document Anonymizer.

Interoperability is essential



Gives importance to data orientation and contributes to sustainability.

Integrates LexNET procedural management and SIR system of interconnection of records. Since the beginning of the project, over 273,000 legal papers have been sent.

Spain has been a pioneer in exchanging information on criminal records through ECRIS.

CTEAJE



It is the co-governance and coordination body between administrations.



The presidency is shared and rotates every two years between the Ministry of Justice and the General Council of the Judiciary.
